

OVERHEAD RETRACTOR INSTALLATION INSTRUCTIONS

MODEL NO. 884-012-5 (3 Ft. Post) 5/8" or 3/4" Hose MODEL NO. 884-016-5 (3 Ft. Post) 1" Hose MODEL NO. 884-013-5 (4 Ft. Post) 5/8" of 3/4" Hose MODEL NO. 884-017-5 (4 Ft. Post) 1" Hose MODEL NO. 884-023-5 (3 Ft. Post) 5/8" or 3/4"Hose w/ M.D. Reel MODEL NO. 884-024-5 (4 Ft. Post) 5/8" or 3/4" Hose, w/ M.D. Reel

NOTE: Do not use any of these models on electronic dispensers. Use Model No. 884-014-5, 884-018-5 (6.5 Ft. Post) or 884-011-5, 884-015-5 (Box Only) instead.

POST INSTALLATION


- 1. Remove the front panel(s) at the top of the dispenser. Drill two 3/8" mounting holes 4" O.C. where the post can be solidly secured through both the sheet metal and upper frame. See Figure 1 below. Use care to avoid interfering with the rest switch or nozzle swing handle.
- 2. Mount the post with the (2) 3/8" 16 x 1" cap screws, (2) lockwashers, (4) flat washers, and (2) nuts as shown in Figure 1.
- Cover the post holes with the (2) caplugs provided.

HOSE INSTALLATION

A 5/8" or 3/4" I.D., U.L. Listed hose up to 17 ft. long is typically used on Model 884-012/884-013/884023/884024*

A 1" I.D., U.L. Listed hose up to 15 ft. long is typically used on Model 884-016/884-017*

- * Hose length referenced is based on standard softwall hose. Mounting configuration, hose type and climate may affect flexibility of hose. (Retractors for use with 5/8" or 3/4" I.D. hose are available with either standard or heavy-duty reels.)
- 1. Slip the hose into the clamp provided and adjust until the bottom of the loop clears the curb. See Figure 2 below. Tighten securely.
- 2. Pull the hose to its full length. It should extend easily and then retract completely.
- 3. If adjustment is required in spring tension, remove the (4) screws from the cover, extend cable approximately 18", wind or unwind one turn at a time and repeat step 2.
