This manual provides instructions for installing the Encore[®], Ecometer[™] Check Valve Kit (K96623-03) on Encore Ecometer units and includes instructions when to install the Ecometer Discharge Adapter (M07297B001) provided in the kit.

Important Safety Information

2) Although DEF is non-flammable, Diesel is flammable. Therefore, for DEF cabinets that are attached to Diesel dispensers, follow all the notes in this section that pertain to flammable fuels.

This section introduces the hazards and safety precautions associated with installing, inspecting, maintaining, or servicing this product. Before performing any task on this product, read this safety information and the applicable sections in this manual, where additional hazards and safety precautions for your task will be found. Fire, explosion, electrical shock, or pressure release could occur and cause death or serious injury, if these safe service procedures are not followed.

Preliminary Precautions

You are working in a potentially dangerous environment of flammable fuels, vapors, and high voltage or pressures. Only trained or authorized individuals knowledgeable in the related procedures should install, inspect, maintain, or service this equipment.

Emergency Total Electrical Shut-Off

The first and most important information you must know is how to stop all fuel flow to the pump/dispenser and island. Locate the switch or circuit breakers that shut off all power to all fueling equipment, dispensing devices, and Submerged Turbine Pumps (STPs).



The EMERGENCY STOP, ALL STOP, and PUMP STOP buttons at the cashier's station WILL NOT shut off electrical power to the pump/dispenser. This means that even if you activate these stops, fuel may continue to flow uncontrolled.

You must use the TOTAL ELECTRICAL SHUT-OFF in the case of an emergency and not the console's ALL STOP and PUMP STOP or similar keys.

Total Electrical Shut-Off Before Access

Any procedure that requires access to electrical components or the electronics of the dispenser requires total electrical shut off of that unit. Understand the function and location of this switch or circuit breaker before inspecting, installing, maintaining, or servicing Gilbarco equipment.

Evacuating, Barricading, and Shutting Off

Any procedure that requires access to the pump/dispenser or STPs requires the following actions:



- An evacuation of all unauthorized persons and vehicles from the work area
- Use of safety tape, cones, or barricades at the affected unit(s)
- A total electrical shut-off of the affected unit(s)

Read the Manual

Read, understand, and follow this manual and any other labels or related materials supplied with this equipment. If you do not understand a procedure, call the Gilbarco Technical Assistance Center (TAC) at 1-800-743-7501. It is imperative to your safety and the safety of others to understand the procedures before beginning work.

Follow the Regulations

Applicable information is available in National Fire Protection Association (NFPA) 30A; *Code for Motor Fuel Dispensing Facilities and Repair Garages*, NFPA 70; *National Electrical Code (NEC)*, Occupational Safety and Health Administration (OSHA) regulations and federal, state, and local codes. All these regulations must be followed. Failure to install, inspect, maintain, or service this equipment in accordance with these codes, regulations, and standards may lead to legal citations with penalties or affect the safe use and operation of the equipment. **Replacement Parts**

Use only genuine Gilbarco replacement parts and retrofit kits on your pump/dispenser. Using parts other than genuine Gilbarco replacement parts could create a safety hazard and violate local regulations.



Working With Fuels and Electrical Energy Prevent Explosions and Fires

Fuels and their vapors will explode or burn, if ignited. Spilled or leaking fuels cause vapors. Even filling customer tanks will cause potentially dangerous vapors in the vicinity of the dispenser or island.

DEF is non-flammable. Therefore, explosion and fire safety warnings do not apply to DEF lines.

No Open Fire



Open flames from matches, lighters, welding torches, or other sources can ignite fuels and their vapors. **No Sparks - No Smoking**



Sparks from starting vehicles, starting, or using power tools, burning cigarettes, cigars, or pipes can also ignite fuels and their vapors. Static electricity, including an electrostatic charge on your body, can cause a spark sufficient to ignite fuel vapors. Every time you get out of a vehicle, touch the metal of your vehicle, to discharge any electrostatic charge before you approach the dispenser island.

Working Alone

It is highly recommended that someone who is capable of rendering first aid be present during servicing. Familiarize yourself with Cardiopulmonary Resuscitation (CPR) methods, if you work with or around high voltages. This information is available from the American Red Cross. Always advise the station personnel about where you will be working, and caution them not to activate power while you are working on the equipment. Use the OSHA Lockout/Tagout procedures. If you are not familiar with this requirement, refer to this information in the service manual and OSHA documentation.

Working With Electricity Safely

Ensure that you use safe and established practices in working with electrical devices. Poorly wired devices may cause a fire, explosion, or electrical shock. Ensure that grounding connections are properly made. Take care that sealing devices and compounds are in place. Ensure that you do not pinch wires when replacing covers. Follow OSHA Lockout/Tagout requirements. Station employees and service contractors need to understand and comply with this program completely to ensure safety while the equipment is down.

Hazardous Materials

Some materials present inside electronic enclosures may present a health hazard if not handled correctly. Ensure that you clean hands after handling equipment. Do not place any equipment in the mouth.

In an Emergency

Inform Emergency Personnel

Compile the following information and inform emergency personnel:

- Location of accident (for example, address, front/back of building, and so on)
- Nature of accident (for example, possible heart attack, run over by car, burns, and so on)
- Age of victim (for example, baby, teenager, middle-age, elderly)
- Whether or not victim has received first aid (for example, stopped bleeding by pressure, and so on)
- Whether or not a victim has vomited (for example, if swallowed or inhaled something, and so on)

\Lambda WARNING

Gasoline/DEF ingested may cause

Before You Begin

Read and understand all safety information found in *MDE-3804 Encore and Eclipse Start-up/Service Manual*.

A clean work area is a requirement for this procedure. It is imperative that no contamination be allowed to enter the Ecometer assembly. Use absorbent towels to clean surface during this procedure.

Meter lockup due to the introduction of contaminants is not covered under warranty.

To prepare the site and dispenser for the installation, proceed as follows:

- **1** Inform the manager.
- **2** Barricade the unit to be worked on.
- **3** Remove power to the unit at the breaker panel and all associated STPs and blenders. Follow OSHA lockout/tagout procedures.
- 4 Match the parts received in the kit with "Parts List" on page 2.

🗥 WARNING

Failure to turn off the unit during kit installation may cause injury or bodily harm from electrical shock. Ensure that all power to the unit is switched off before opening the door to the unit and during kit installation.

Testing Two-stage Valves

Testing two-stage valves for leaks is necessary to make sure the valves remain closed (not leaking) when not engaged.

To test the valves for leaks, proceed as follows:

- Note: To determine if a valve leaks, the line must be pressurized, the valve must be deactivated, and the nozzle must be opened. If the meter turns, the valve is leaking and must be replaced or rebuilt before proceeding.
- 1 Place the nozzle into approved container before activating.
- 2 Apply line pressure while the valve is deactivated. This can be done two ways:
 - The coil of the valve being tested can be removed or disconnected and then the nozzle handle associated with that valve can be engaged. This will turn on the STP and apply line pressure. (This would normally open the valve, which is why it has been disconnected.).
 - The STP of the grade being tested can be activated by engaging the nozzle handle on the opposite side of the pump from the valve being tested. Then the nozzle can be opened and the meter checked to determine if any leakage is occurring. For example, to test mid-grade side A valve, turn on mid-grade side B (flip side B nozzle handle), open mid-grade side A nozzle and observe mid-grade side A meter.

- **3** Observe meter for one minute. If the meter rotates, replace or rebuild the Two-stage Valve (R19093-02) using the Solenoid Repair Kit.
- 4 After all valves have been tested, proceed to "Removing Existing Ecometer".

Removing Existing Ecometer

To remove the existing Ecometer, proceed as follows:

Note: Read and follow all safety precautions in "Important Safety Information" on page 3.


- **1** Remove the outer and inner side sheathings.
- 2 Close and test all shear valves on dispensers to check that they seal mechanically.
- **3** Press **CLEAR** then **ENTER** on the manager keypad.
- **4** Open the nozzle into approved container to bleed pressure. Some residual pressure may remain.
- 5 Remove the Ecometer discharge line flange and meter inlet line flange bolts.*Note: Support the Ecometer when removing bolts.*
- 6 Remove the Ecometer bracket bolts. *Note: It is not necessary to remove the bracket.*

Installing Encore, Ecometer Check Valve Kit

To install the Encore, Ecometer Check Valve Kit, proceed as follows:

- Note: Check if the Ecometer Discharge Flange (M08513B010) has a "notch" as shown in Figure 1. If yes, discard the Ecometer Discharge Adapter (M07297B001) supplied with this kit and install Meter Check Valve Assembly (N23619-G4) directly into the Ecometer discharge flange along with the O-rings.






Figure 3: Dismantling Meter Assembly

- 1 Remove existing O-rings and meter check valve assembly (see Figure 3 on page 8).
- 2 Inspect and clean the discharge plate and the discharge line mounting surface.

Figure 1: Modified Ecometer Discharge Flange (M08513B010) and Ecometer Discharge Adapter (M07297B001)

3 Lubricate the two large M08023B001 O-rings with silicon grease. Insert N16891-41 and N16891-33 O-rings into the groove in Encoder Ecometer (M07299B001).

4 Lubricate and insert the smallest N16891-41 O-ring into the groove in Ecometer Discharge Plate [M07512B001 (see Figure 3 on page 8)].

- 5 Insert the meter check valve assembly into the Ecometer discharge adapter.Note: Ensure the check valve spins freely in the outlet flange so that there is no interference (to ensure that proper outlet flange is used).
- 6 Lubricate and insert the N16891-33 O-ring into the groove in the Ecometer discharge adapter, (see Figure 4).
- 7 Assemble the unit which was prepared in step 3 on page 8 by using the four Metric Socket Head Cap Screws M6 X 50 (M07620B001).
- **8** Bolt the Ecometer assembly to mounting brackets and pipeline flanges.

Completing Installation

To complete installing the Encore, Ecometer Check Valve Kit, proceed as follows:

- **1** Replace the side sheathing.
- **2** Open the shear valves.
- **3** Turn on the unit and STP power.
- **4** Purge air 25 gallons (95 liters) and check for leaks.
- **5** Calibrate the meter.

Installing the Encore, Ecometer Check Valve Kit is now complete.
