A certified installing contractor is required to complete an initial site survey prior to installation. Gasboy will review the site survey and work jointly with the installing contractor to develop a Site Preparation Plan. Gasboy will directly monitor and support sites during the initial stages.

Gasboy has successfully installed PCI compliant applications on the NBS and Paymentech networks. The software for NBS and Paymentech is production released and available for shipment. The Buypass network application is scheduled for production release in July. Please continue to check with Gasboy Technical Support at (800) 444-5529 for the most current information on timing of the individual network software releases.

We look forward to working in partnership with you to bring your customers' CFN III Site Controller systems into compliance with these new requirements. Please contact your Gasboy representative if you require additional information.

To meet current market needs, Gasboy will continue to supply limited models of the old style A & E model dispensers (8753EX and 9853AX) recommended for alternative fuel applications while the Gasboy® Atlas® E85 dispenser is under development. The recommended applications for these A & E models are limited to E85, M85 and Biodiesel blends greater than B20. Refer to SP-7153 for details.

The Gasboy® Model 52A Pressure Regulating Valve (048577PG8) is on ship hold. Release will require UL approval. We expect this to be complete the week of September 7. We will resume shipping upon approval.

Your Customer Service Representative will be contacting you about your Model 52A valve orders. There are third party valves available and suitable for use in this application that will allow you to install Gasboy dispensers during this period.
