Read this Agreement Carefully Before Opening the Software

THE TERMS OF THIS LICENSE AGREEMENT APPLY TO DISTRIBUTORS AND END-USERS AS THE ORIGINAL LICENSEE AND TO ANY SUBSEQUENT LICENSEE OF THIS PAM 1000 SOFTWARE LICENSED PRODUCT.

Gilbarco Inc. retains ownership of all rights in this version and copy of this PAM 1000 Software Licensed Product. The PAM 1000 software is referred to hereinafter as "the Licensed Product." This copy of the Licensed Product is licensed to you according to the following terms and conditions, and you should carefully read such terms and conditions before opening the package. Opening the package or other means of agreement (e.g. notice without objection before using the Licensed Product or electronic acceptance) constitutes your agreement to and acceptance of these terms and conditions. If you do not agree to and accept them, promptly return the package unopened and/or stop using the Licensed Product immediately and your money will be refunded. You agree to take full responsibility for its use to achieve your intended purpose and for the installation, use, and results obtained from the program.

LICENSE

You May:

Use the Licensed Product, provided that the Licensed Product is used in only one pump access module at a time.

1. Distribute, rent, sublicense, or lease the Licensed Product or documentation provided that the end-user agrees in writing or other means of agreement referenced above to adhere to the terms of this Agreement.
2. Transfer the Licensed Product to another Party if the other party agrees in writing to the terms and conditions of the Gilbarco License Agreement. If you transfer the Licensed Product, you must at the same time transfer the documentation, the pump access module in which the software was installed, and all application and operation media.

Prohibited Uses

You May NOT, without written permission from Gilbarco:

1. Make copies of the Licensed Product.
2. Install and/or use the Licensed Product on more than one pump access module at one time.
3. Alter, modify or adapt the Licensed Product or documentation, including, but not limited to translating, decompiling, disassembling, reverse compiling, reverse engineering, or creating derivative works of any part of the Licensed Product.
4. Sublicense, assign, or transfer the license of the program except as expressly provided in this Agreement.
5. Transfer the Licensed Product to a pump access module other than the one it was delivered with or installed on initially. A new license must be purchased with any new or used pump access module hardware.
6. Use the Licensed Product to control or connect to gasoline pumps or dispensers located at a street address different from that where the pump access module is located.

TERM

The License Agreement and your right to use the Licensed Product will automatically terminate upon your failure to comply with any provision of the License Agreement.

GENERAL

Gilbarco retains all rights including all copyrights, not expressly licensed or granted. Nothing in this Agreement constitutes a waiver of Gilbarco's rights under the U.S., or any other copyright laws or any other Federal or State law. PAM™ 1000 is a trademark of Gilbarco. Nothing in this Agreement grants any rights to the end-user to any Gilbarco trademark. The laws of North Carolina govern this Agreement. The PAM 1000 Software shall not be exported by you except in compliance with applicable United States governmental regulations.

NOTICES

Licensee agrees that it shall not remove or alter any copyright notices in or on the Licensed Product when using and distributing.

Limited Warranty

If you discover physical defects in the media on which the Licensed Product is distributed, Gilbarco Inc. will replace the media or documentation at no charge to you provided that you return to Gilbarco the items to be replaced, with proof of payment. You have this right to replacement for a period of ninety (90) days after receipt of the Licensed Product.

GILBARCO WARRANTS THAT THE LICENSED PRODUCT AND GILBARCO PRODUCTS WHOSE OPERATION IS CONTROLLED BY GILBARCO COPYRIGHT-PROTECTED LICENSED PRODUCT SHALL BE FREE OF MATERIAL DEFECTS AND CONFORM TO CURRENT GILBARCO SPECIFICATIONS FOR A PERIOD OF NINETY (90) DAYS FROM THE DATE OF SHIPMENT TO YOU. GILBARCO SHALL USE ITS REASONABLE EFFORT TO CORRECT SUCH MATERIAL DEFECTS AND TO SHIP TO THE LICENSEE/PURCHASER A CORRECTED VERSION OF THE SOFTWARE WITHIN A REASONABLE TIME AFTER LICENSEE NOTIFIES GILBARCO IN WRITING OF ANY DEFECTS AND PROVIDES THE PROGRAMS AND/OR INSTRUCTIONS REQUIRED TO REPRODUCE THE CLAIMED DEFECT.
